OFFICIAL RULES

The "Prairie Band PFT" (hereinafter, the "Tournament") is a sports tournament that will be conducted between 9:00 AM on Friday, August 1, 2025, and ending at 1:59 AM on Wednesday, January 7, 2026, at the Prairie Band Casino & Resort, 12305 150th Road Mayetta, KS 66509. All references to time of day refer to Central Time (CT). All specific dates are subject to change once the National Football League ("NFL") weekly schedule is released; in which case these Rules will be updated to reflect any such changes.

- There is a \$100 fee per entry. All entry fees are non-refundable unless the Tournament is canceled by Prairie Band Casino & Resort pursuant to Rule 14. Allowable methods of payment include cash or Prairie Band Casino & Resort gaming chips.
- 2) All entrants must be at least 21 years of age to participate. Entrants must provide valid government picture identification prior to entry. All submitted entries are subject to potential third-party verification. All entrants must also be a current cardholder of "The Players Club®." The Players Club card is free and available at the Prairie Band Casino & Resort Players Club.
- Entrants may purchase a maximum of ten (10) entries per person. Purchasing more than ten (10) entries will result in disqualification from the Tournament without any refund. Entrants who have multiple entries earning prizes will be paid for each entry's corresponding prize dollar amount.
- Registrations and payment of entry fees for this Tournament will be accepted at the Prairie Band Casino & Resort Cashiers Cage or Sportsbook beginning at 9:00 AM on Friday, August 1, 2025, and will be accepted until 12:00 PM on Sunday, September 7, 2025. **Entrants may start making Week 1 selections on Monday, August 25, 2025**.
- 5) The Tournament is won by accruing as many points as possible, based on five (5) weekly NFL selections against a static point spread. Entrants will be awarded one (1) point for each correct selection, one half (.5) point for each push, and zero (0) points for each incorrect selection. Entrants may not select both sides of the same game on a single entry. In the event an entrant has multiple entries, they may select one side of the game on one (1) entry and the opposite side of the same game on any other entry.
- Tournament point spreads will be available at approximately 4:00 PM each Tuesday during the Tournament period. Weekly selections must be submitted at Prairie Band Casino & Resort during each selection period (4:00 PM Tuesday 12:00 PM Sunday) via personal mobile device/computer connected to the "PBC_Guest" wifi network **and/or** by Tournament Laptops located in Prairie Band Sportsbook). The deadline for weekly selections is 12:00 PM each Sunday during the duration of the Tournament. **Attempts to make selections after this deadline will not be accepted**. In the event an entrant is unable to submit their selections before the weekly deadline, he/she will be awarded zero (0) points for that week. Missing a deadline in no way prevents an entrant from submitting selections in subsequent weeks during the Tournament.
- 7) Entrants who would like to select games that occur prior to the selection deadline (for example, Thursday Night Football) must submit all five (5) of their selections prior to kickoff of the earliest game they are selecting that week. **Partial submissions will not be accepted**.
- 8) Prairie Band Casino & Resort is not responsible for any technical difficulties, malfunctions or any other unforeseen issues regarding use of the Tournament platform. Technical malfunctions of the Tournament platform will not change the selection deadline under any circumstances.
- By signing a Tournament registration form, an entrant designates themselves as an "Official Entrant".
- Entrants may make an unlimited amount of changes to their selections until 12:00 PM each Sunday, as long as none of their selected games has kicked off.
- 11) Prize Structure:
 - a. The prize pool will consist of a guaranteed \$11,400 in total. The prize pool will be funded with Tournament entry fees and supplemented by Prairie Band Casino & Resort should the number of entries be less than 114. All Full Season prize payouts will be made in cash, check, casino chips or a combination thereof at the winner's election.
 - b. Should the number of total entries be between 115 and 199, 100% of any additional entry fees will be split equally between Full Season Places 1-7 and Full Season Last Place.
 - c. Should the number of entries total 200 or more, 8th, 9th, and 10th place prizes will be added with the following percentages applying to Full Season prizes:

1st Place: 36% of the total prize pool 2nd Place: 20% of the total prize pool 3rd Place: 10% of the total prize pool 4th Place: 8% of the total prize pool 5th Place: 7% of the total prize pool 6th Place: 5% of the total prize pool 7th Place: 4% of the total prize pool 8th Place: 3% of the total prize pool 9th Place: 2% of the total prize pool 10th Place: 1% of the total prize pool Last Place: 4% of the total prize pool

d. The following tiebreaking Rules will only be applied to determine the overall Full Season 1st Place winner. In the event of a tie for 1st Place, the winner will be determined based on the entrant that accumulated the most Tournament wins during the eighteen (18) weeks of the regular season. If total wins accumulated during the eighteen (18) weeks are equal, then the tiebreaker will revert to the entrant who has accumulated the most winning weeks. A winning week is defined as accumulating more than 2.5 points in a given Tournament week. If total winning weeks accumulated during Weeks 1-18 are equal,

then the tiebreaker will revert to the entrant who has accumulated the most undefeated (5-0) weeks during the regular season. If most undefeated (5-0) weeks accumulated during Weeks 1-18 are equal, then the tiebreaker will revert to the entrant who has accumulated the most undefeated (4-0-1) weeks during the regular season. If most undefeated (4-0-1) weeks accumulated during Weeks 1-18 are equal, then the tiebreaker will revert to the entrant who has accumulated the most (4-1) weeks during the regular season. In the event of a tie after application of all tiebreakers, multiple 1st Place winners will be declared, and the aggregate prize money will be split equally amongst the number of entrants tied for 1st Place

- e. All ties for Quarterly and/or Full Season prizes for finishing positions including 1st Place (that are not described above) will be split evenly among all entrants in the tie. (For example, if two entrants are tied for 1st Place, the prizes for 1st and 2nd place will be added together and split evenly. Official finishing position for these two entrants would be "T-1st", and the next finisher in this situation would finish 3rd. Additionally, for example, if two entrants are tied for 2nd Place, the prizes for 2nd and 3rd place will be added together and split evenly. Official finishing position for these two entrants would be "T-2nd", and the next finisher in this situation would finish fourth, etc.).
- f. Schedule for Quarterly Free Play Prizes:
 - i. 1st Quarter: Weeks 1-4
 ii. 2nd Quarter: Weeks 5-9
 iii. 3rd Quarter: Weeks 10-13
 iv. 4th Quarter: Weeks 14-18
 - v. Prairie Band Casino & Resort reserves the right to redefine the quarterly schedule if the NFL schedule changes at any time. Tournament Weeks (and the corresponding Quarter they are originally a part of) that are already completed will not be subject to any redefinition.
- g. Quarterly Free Play Prizes:
 - i. The following prize structure will be used:
 - 1. 1st Place \$500 Free Bet (or Prairie Cash)
 - 2. 2nd Place \$400 Free Bet (or Prairie Cash)
 - 3. 3rd Place \$300 Free Bet (or Prairie Cash)
 - 4. 4th Place \$200 Free Bet (or Prairie Cash)
 - 5. 5th Place \$100 Free Bet (or Prairie Cash)
 - ii. In the event of a tie for any Quarterly prize (even the 1st Place prize), prizes will be divided as described in Section 11d. If the NFL season does not complete four (4) full weeks to complete the Quarter, prizes will be awarded according to point standings at the time of cancellation (provided at least one (1) full Tournament Week of the Quarter has been completed). After the final winners are posted on the Tuesday immediately following the conclusion of the Quarter, a three (3) day audit period will occur and thereafter payouts will be awarded on the following Saturday. Any disputes must be made in writing to Prairie Band Casino & Resort during the three (3) day audit period. At the end of the three (3) day audit period, the Prairie Band Casino & Resort Quarterly prize winners will be official and final.
 - Tournament Weeks (and the corresponding Quarter they are originally part of) that are already completed will not be subject to any redefinition.
- h. A prize payout may be issued by completing an IRS Form 5754. The Official Entrant must appear in person at Prairie Band Casino & Resort and is subject to the requirements set forth in Rule 2 above before any individual payouts will be awarded for the prize payout.
- 12) The Tournament will be considered official after Week 12 of the NFL season begins. If the NFL season does not run at least twelve (12) full weeks, all Tournament entry fees will be refunded. If the NFL season is not completed as scheduled but lasts twelve (12) full weeks or more, the point leader at the time the season is canceled will be declared the winner. This Rule in no way affects the Quarterly free play payouts. If material technical difficulties or other Acts of God prevent the Tournament from being completed after Week 12, the Tournament will still be action, and prizes will be awarded based on current point totals at the time of cancellation.
 - a. If the NFL season is suspended (but not outright canceled), the Tournament will be suspended until the season resumes. If 90 days pass with no NFL game being completed, the Tournament will end, and entry fees will either be refunded (if before Week 12 is completed) or prizes will be awarded based on current point totals at the time of cancellation (if during or after completion of Week 12). This Rule will also apply to Quarterly free play payouts.
- 13) All Prairie Band Sportsbook House Rules shall also apply to this Tournament, unless otherwise stated in these Rules.
- Prairie Band Casino & Resort reserves the right to refuse entry to any person in its sole and absolute discretion. Individuals who are listed on the Excluded Persons List or any other exclusion list, shall not be eligible to participate in the Tournament or win any prizes or monies. Additionally, Prairie Band Casino & Resort may cancel this Tournament or refuse to accept any entry or weekly selection if there are concerns that any rule, regulation, or law that may govern this Tournament may be violated.
- Prairie Band Casino & Resort will make a reasonable effort to find alternative methods of accepting weekly selections in the event of a computer system failure.
- Solely for Tournament purposes, all games are "action" despite any change in a game's location. If a game deviates from its originally scheduled time and location, the game must be completed by 1:59 AM on Wednesday of the Tournament Week in order for it to be eligible to be graded as a "win", "loss", or "push". A "Tournament Week" shall mean seven (7) consecutive calendar days starting on Wednesday at 2:00 AM and ending on the following Wednesday at 1:59 AM.
 - a. Selections in any game that do not have a Win-Loss result from the NFL by the end of the Tournament Week as defined above will be graded as a push for the Tournament and awarded a one half (0.5) point. Subsequently, if the NFL awards a win and a loss for a game before the Tournament Week ends and without the game being played (as in the case of a forfeit), any selections for the winning team as deemed by the NFL will automatically cover the Tournament point spread and be scored as 1 point. Any selections for the losing team as deemed by the NFL will be scored as zero (0) points.

- 17) After the final Tournament winners are posted, a five (5) day audit period will occur. Any disputes with the Tournament and/or the results or prize awards must be provided to Prairie Band Casino & Resort in writing within such audit period. At the end of the five (5) day audit period, the Tournament results will be declared official and final, and payouts will be awarded at the conclusion of this audit period. In the event of any dispute, Prairie Band Casino & Resort's decision will be final.
 - b. All Tournament payouts must be collected in person by the Official Entrant within 365 days from the time that payouts commence. If an entrant fails to collect in person any prize or monies awarded to them after this period, Prairie Band Casino & Resort will mail a check to the last address of residence listed on the Tournament Entry form after exhausting all efforts (phone, text, email, etc.) to contact the Official Entrant.
 - i. If an Official Entrant dies during the Tournament and is owed any monies from winnings, then pursuant to the executor of the Entrant's estate showing Prairie Band Casino & Resort both a death certificate of the Official Entrant and documentation that he/she is the executor of the estate, then at that time Prairie Band Casino & Resort will make payment in the form of cash and/or a check to the executor of such estate.
- 18) No employee of Prairie Band Casino & Resort may participate in the Tournament.
- All entrants authorize Prairie Band Casino & Resort unconditional and unrestricted use of their likeness, image, and name in any marketing, promotional, or advertising materials free of any consideration and/or compensation. Prairie Band Casino & Resort holds sole and absolute discretion regarding the content of any promotional, advertising, marketing, or announcement material regarding this Tournament and any winners thereto.
- All decisions regarding the interpretation of these Rules for the Tournament are solely within the absolute discretion of Prairie Band Casino & Resort, whose decisions shall be final. Prairie Band Casino & Resort reserves all rights and may modify the Tournament for any reason.
- Any reasonable suspicion of fraud or otherwise dishonest conduct on behalf of an entrant may result in disqualification from the Tournament without refund.
